RESOLVED, that this Town Board of the Town of New Bremen, did review the Tentative Budget of this town for fiscal year beginning January 1, 2020. Itemized estimates of salaries and expenses are on file in the Town Clerk's Office and made a part of this resolution; and now, therefore be it further
